**RELEASE AND WAIVER OF LIABILITY**

THIS RELEASE AND WAIVER OF LIABILITY (the "Release") is given on this 3rd day of June, 2017 , by \_\_\_\_\_ ("Volunteer") in favor of Bridges of Hope and all its affiliates, located in New Haven, Connecticut. ("Bridges of Hope"), and its directors, officers, employees, and agents, and the heirs, executors, personal representatives, successors and assigns of each of them ("Bridges of Hope").

Volunteer desires to work as a volunteer for I HEART DAY. Volunteer does hereby freely, voluntarily, and without duress, give this Release under the following terms:

**1. Waiver and Release.** Volunteer does hereby release and forever discharge and hold harmless each of the Bridges of Hope affiliates from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Volunteer's activities with respect to the project and does covenant not to sue Bridges of Hope and its affiliates with respect to such matters.

Without limiting the generality of the foregoing, Volunteer understands and agrees that this Release discharges Bridges of Hope and its affiliates from any liability or claim that Volunteer may have against any of them with respect to any bodily injury, personal injury, illness, death, or property damage that may result from Volunteer's activities with respect to the project, whether caused by the negligence of Bridges of Hope and its affiliates or otherwise. Volunteer also understands and agrees that Bridges of Hope and its affiliates does not assume any responsibility for or obligation to provide financial assistance or any other assistance in the event of injury or illness.

**2. Medical Treatment.** Volunteer does hereby release and forever discharge Bridges of Hope and its affiliates from any claim whatsoever which arises on account of any first aid, treatment or service rendered in connection with the Volunteer's work on the project.

**3. Assumption of the Risk.** Volunteer understands that the work on the project may include activities that may be hazardous to the Volunteer, including, but not limited to, construction and repair, painting, moving furniture and appliances, loading and unloading construction supplies and equipment, trash removal, use of tools and equipment, and transportation to and from work sites. Volunteer hereby expressly and specifically assumes the risk of injury or harm in these activities, whether caused by the negligence of Bridges of Hope and its affiliates or otherwise.

**4. Insurance.** Volunteer understands that Bridges of Hope and its affiliates does not carry or maintain health, medical, or disability insurance coverage for any Volunteer.

**6. Other.** Volunteer expressly agrees that this Release is intended to be as, but only as, broad and inclusive as permitted by the laws of Connecticut. Volunteer agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release, all of which shall continue to be enforceable.
